Know all men by these presents that Wm.Martineau, the party of the first part, for and in consideration of the sum of One Dollar lawful money of the United States in hand paid by H.J.Harris, the party of the second part, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned transferred and set over and by these presents does grant, bargain, sell, assign, transfer and set over unto the said party of the second part a certain Intendure of Mortgage bearing date the 21st day of Spt. 1908 made and executed by A.W.Erickson to the said party of the first part, to secure the payment of the sum of four hundred twenty five dollars, together with the promissory note or obligation therein described and the money due or to grow due thereon with the interest, which said intendure of Mortgage was recorded in the office of the Recorder of the County of Skamania, State of Washington in Book H of Mortgages, page 288 on the 22nd day of Sept. 1908.
