Know all men by these presents that we, J. M. Coulter and Florence F. Coulter, husband and wife do considerate of \$ 982.40 to them in hand paid by W. C. Rupert and L. E. Crowe, the receipt whereof is hereby acknowledged, do hereby give, grant, bargain, sell and convey to the said W. C. Rupert and L. E. Crowe and unto their heirs and assigns forever all the following described land lying and being situate in Skamania County, Washington, to wit: The South half of the North-west quarter and the South half of the North-east quarter of Section ten; also the west half of the South-east quarter and the East half of the South-west quarter of said Section ten, all in Township Three North, Range Nine East, Willamette Meridian, containing three hundred and twenty acres, according to the Government survey. Together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in any wise appertaining. To have and to hold the above described premises and appurtenances unto the said W. C. Rupert and L. E. Crowe and unto their heirs and assigns forever. And we the said J. M. Coulter and Florence F. Coulter, for ourselves, our and each of our heirs, executors and administrators, do hereby covenant to and with the said W. C. Rupert and L. E. Crowe, their heirs and assigns, that we are the owners in fee simple of the above granted premises; that we have good right and title to convey the same in manner aforesaid; that they are free from all incumbrances; that we will and our heirs, executors and administrators shall warrant and defend the same and the valuable possession thereof unto the said grantees herein, their heirs and assigns against the lawful demands of all persons except the claim of the Oregon Lumber Co. under contract recorded in Book One of Bills of Sale of said County of Skamania at page 202.
