Bethea, the party of the first part, for and in consideration of twelve hundred and fifty Dollars to me in hand paid by Walter Duggan of Cape Horn Skamania County State of Washington, the party of the second part, the receipt whereof is hereby acknowledged, have granted, bargained, sold assigned, transferred and set over and by these presents do grant, bargain, sell assigns transfer and set over unto the said party of the second part, a certain Indenture of Mortgage bearing date the 24th day of April 1908 made and executed by MacArthur H. Fullerton to me, F.E.
