I.O.O.F. to Bank of Stevenson

This Indenture Made this 14th day of May 1909 between Mountain Lodge No. 172, Independent Order of Odd Fellows, by its Board of Trustees, party of the first part, and Bank of Stevenson, a corporation organized under the laws of Washington, party of the second part: Witnesseth:

That the said party of the first part for and in consideration of the sum of five hundred dollars lawful money of the United States, to it in hand paid by the said party of the first part the receipt whereof is hereby acknowledged, does by these presents grant bargain sell and convey unto the said party of the second part and to its successors and assigns the following described tract parcel of land lying and being in the County of Skamania, State of Washington, to-wit: Lots numbered one and two in Block seven of the original Town of Stevenson, as shown by the official plat of said town now on file and of record in the office of the Auditor for Skamania County Washington, together with all and singular the tenements, hereditaments and appurtenances therunto belonging. This conveyance is intended as a mortgage to secure the payment of Five hundred dollars lawful money of the United States, together with interest thereon at the rate of 8 per cent per annum from date until paid, according to the terms of one certain promissory note bearing date the 14th day of May 1909 made by Mountain Lodge No. 172 I.O.O.F. payable on or before one year after date to the order of the Bank of Stevenson, and these presents shall be void if such payment be made according to the terms and agreements thereof. But in case default be made in the payment of the principal or interest of said promissory note or any part thereof, when the same shall become due and payable, according to the terms and conditions thereof, then the said
