Sweeney to Bank of Stevenson.

Sweeney, his wife, of Stevenson, Washington, parties of the first part, and Bank of Stevenson, a Washington corporation, of Stevenson, Washington, party of the second part: Witnesseth, That the said parties of the first part, for and in consideration of the sum of Five Hundred and no/100 (\$500.00) Dollars lawful money of the United \$tates, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents, Grant, Bargain, Sell, Convey, and Warrant unto the said party of the second part, and to its successors and assigns, the following described tract or parcel of land, lying and being in the County of Skamania and State of Washington, and Particularly bounded and described as follows, to-wit: The Northeast Quarter of the Northwest Quarter, the Northwest Quarter of the Northeast Quarter and Lots numbered Five and Six of Dection Thirty-one in Township Three North of Range Eight Wast of W.M., excepting therefrom a strip of land heretofore deeded to the Spokane, Portland and Seattle Railway company for right of way, and excepting a strip of land six hundred feet wide and fifteen hundred feet long pointed on the north line of the above described property, on the west by a line parallel to the three hundred feet west of the center line of the lead of the Columbia Gold and Copper withing Company's mine, and on the east by a line parallel to and three hundred feet east of the center line of the said lead, together with all and singular the tenements, hereditaments and a purten ances thereunto belonging.

This Conveyance is intended as a Mortgage to secure the payment of Five Hundred and no/100 (\$500.00) Dollars, lawful money of the United States, together with interest thereon at the rate of One per cent. per month from date until paid, according to the terms and conditions of a certain promissory note bearing date May 18th.1909, made by John F. Sweeney & Mary E.Sweeney payable six months after date to the order of Bank of Stevenson and these presents shall be void if such payment be made according to the terms and conditions thereof. But in case default be made in the payment of the principal or interest of said promissory note, or any part thereof, when the same shall become due and payable, according to the terms and conditions thereof, then the said party of the second part, its accessors or assigns, may immediately thereafter, in the manner provided by daw, foreclose this mortgage for the whole amount due upon said principal and interest, with all other sums hereby secured.

In any suit or other proceeding which may be had for the recovery of the amount due, on either said note or this mortgage, said party of the second part, its successors or assigns shall have the right to have included in the judgment which may be recovered the sum as the court may adjudge reasonable as attorney's fees, to be taxed as part of the costs in such suit, as well as all payments which the said party of the second part, its successors and assigns may be obliged to make for its or their security by insurance or on account of any taxes, charges, incumbrances or assessments whatsoever on the said premises or any part thereof.

In case of the foreclosure of this mcrtgage, the party of the second part, its successors or assigns shall be entitled to have entered in such foreclosure suit a judgment for any deficiency remaining due upon account of the indebtedness secured hereby, including taxes, insurance or other lawful assessments after applying the proceeds of the sale of the premises above described to the payment thereof, and to the costs of such foreclosure suit.
