

H. H. Mc. Carthy to Barney O'Neil

Know all men by these Presents: That I, H. H. Mc. Carthy, in consideration of the sum of Three Thousand Dollars to Barney O'Neil paid by Barney O'Neil, do hereby remise, release and forever quitclaim unto the said Barney O'Neil, and unto his heirs and assigns, all my right, title and interest in and to the following described mines, situated in St. Helens Mining District, County of Skamania, State of Washington, to-wit:

Known as the Umatilla Claim No. 2: Beginning at the center of what is known as Lake Creek, a tributary to the North Lewis River, about 600 feet below or east of Camp O'Neil, and about 500 feet west of the Homestake Discovery, and about $4\frac{1}{2}$ miles east of Spirit Lake, and about 20 feet N.W. of mouth of tunnel on Umatilla No. 1, and running 1500 feet 15 deg. east of north, and 300 feet on each side of center of said line.

Known as the Eureka Claim No. 2: Beginning at center of Lake Creek (a tributary to the North Lewis River) at a prominent Falls and where a tunnel of 20 feet has been made, and running from there 1500 feet 30 deg. north of west, and 300 feet on each side of said line. The Discovery is more fully described as follows: It is about two miles southeast of Lake Meta, and about four miles east of Spirit Lake, and about 600 feet west of O'Neil's Mining Camp.

Known as the King Edward Claim No. 2: Beginning at center of what is known as Lake Creek (a tributary to the North Lewis River) about $2\frac{1}{4}$ miles south east of Lake Meta, and about 4 miles east of Spirit Lake, and about 500 feet east of Eureka Tunnel, and 350 feet west of O'Neil's Mining Camp, and running 1500 feet in a north west direction and 300 feet on each side of center of said claim.

Known as the Hidden Treasure Claim No. 1: Beginning at center of what is known as Erwin Creek near where it runs into Lake Creek, (a tributary of the North Lewis River) about $1\frac{1}{2}$ miles south east of Lake Meta, and about 3 miles east of Spirit Lake, and about 1 mile west of O'Neil's Mining Camp, and about 1 mile south of Mt. Bismark, and running 1500 feet south east, and 300 feet on each side of said line.

Known as the Homestake Claim No. 2: Beginning at center of what is known as Lake Creek, a tributary to the North Lewis River, and running 1500 linear feet north west, and 300 feet on each side of said line. The Discovery is situated about 1000 feet below or east of Camp O'Neil, and about $4\frac{1}{2}$ miles east of Spirit Lake, and about 100 feet west or above the mouth of Ghost Lake Creek, and its boundaries are marked on the ground by blazes and post.

Known as the Victoria Claim No. 2: Beginning at a point about 600 feet from mouth of Poor Man's Gulch, where it runs into Lake Creek, about 200 feet east of Camp O'Neil, and about 800 feet south west of Umatilla Discovery, and about 4 miles east of Spirit Lake, opposite a point where Location Notice is posted, and running 1500 feet north west, and 300 feet on each side of center of said line.

Known as the Bohemia Claim No. 2: Beginning opposite Discovery post where Location Notice is posted on what is known as Poor Man's Gulch about $\frac{1}{2}$ mile south east of Camp O'Neil, and about 2000 feet south east of King
