

NOTICE OF TAX LIEN UPON REAL PROPERTY

Cornwall, Skamania County Treasurer, have this day determined pursuant to the authority vested in me by RCW 84.60.020 and 84.60.040 that it is necessary that the following described real property be, and the same hereby is, selected, designated and charged with unpaid personal property taxes as set forth, to wit:

BEGINNING AT THE NORTHEAST CORNER OF THE SE1/4 OF THE NW1/4 OF THE SAID SECTION 8; THENCE SOUTH 660 FEET ALONG THE EAST LINE OF THE SE1/4 OF THE NW1/4 OF THE SAID SECTION 8; THENCE WEST 660 FEET PARALLEL TO THE SOUTH LINE OF THE NW 1/4 OF THE SAID SECTION 8 TO THE TRUE POINT OF BEGINNING; THENCE WEST 660 FEET PARALLEL TO SAID SOUTH LINE; THENCE NORTH 330 FEET PARALLEL WITH THE EAST LINE OF THE NW1/4 OF THE SAID SECTION 8; THENCE EAST 660 FEET PARALLEL TO THE NORTH LINE OF THE NW1/4 OF THE SAID SECTION 8; THENCE SOUTH 330 FEET TO THE TRUE POINT OF BEGINNING;
