

A. J. Wiley to W. A. Gray.

This Indenture, Made the nineteenth Day of August in the year of our Lord, one thousand nine hundred and three, between A. J. Wiley of Pacific County, State of Washington party of the first part, and W. A. Gray of Lewis County, State of Washington, part of the second part, Witnesseth: That the said party of the first part, for and in consideration of the sum of One Thousand Dollars of the United States of America, to me in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, has granted, bargained, sold, remised, released and forever quitclaimed, and by these presents do grant, bargain, sell, remise, release and forever quitclaim, unto the said party of the second part, and to his heirs and assigns, Mining Claims, known as Lakeside Lead No. 1, about one thousand feet North of Spirit Lake, Beginning at Location post and running N. E. 300 ft, thence 1500 ft N. W., thence 600 ft S. W., thence 1500 ft S. E., thence 300 ft N. E. to place of beginning. Also Lakeside Lead No. 2. Beginning at aforesaid Location Post and running 300 ft N. E., thence 1500 ft S. E. thence 600 ft S. W. thence 1500 ft N. W. thence 300 ft N. E. to place of beginning.

Together with all the dugs, spurs, and angles, and also all the metals, ores, gold and silver bearing quartz, rock and earth therein, and all the rights, privileges and franchises thereto incident, appendant and appurtenant, or therewith usually had and enjoyed, and also all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining, and the rents, issues and profits thereof, and also all the estate, right, title and interest, property, possession, claim and demand whatsoever, as well in law and equity, of the said party of the first part, of in or to the said premises, and every part and parcel thereof, with the appurtenances. To Have and to Hold, all and singular, the said premises, together with the appurtenances and privileges thereto incident, unto the said party of the second part, his heirs and assigns forever.
