Know all Men by these Presents; That Willis H. Gilbert and Milly L. Gilbert, his wife of Ashland, Ashland County, Wisconsin, parties of the first part, in consideration of the sum of One Dollar <\$1.00> to them duly paid, do hereby remise, release and quitclaim unto A. L. Ordeau, C. F. Latimer and John J. Ruggs, Trustees of the estate of Willis H. Gilbert, parties of the second part, and to their heirs and assigns, the following described real estate, situated in the County of Skamania, State of Washington, to-wit:

The Southwest quarter, and southwestquarter of southeast quarter of section eight (8), west half, southeast quarter, and west half of northeast quarter of Section seventeen (17), southwest quarter of southwest quarter of section fifteen (15), southeast quarter of section twenty (20), south-half of south-half of section twenty-one (21), west half of Section twenty-two (22), north-half of north-half, and southeast quarter of northwest quarter of section twenty-eight (28), northwest quarter of northwest quarter of section twenty-nine (29) east-half of northeast quarter of section thirty (30) in Township six (6) north of range five (5) east of Willamette Meridian, containing seventeen hundred and sixty <1760> acres, more or less,

The north-half, north-half of southwest quarter, and north-half of southeast quarter of section twenty-one (21) in Township six (6) north of range five (5) east of Willamette Meridian, containing four hundred and eighty <480> acres, more or less,

The northwest quarter of the Southwest quarter of section number fifteen (15); the southwest quarter of the Southeast quarter of section number twenty-eight (28); the east-half of the southeast quarter of section number thirty-two (32); the northeast quarter, the south half of the northwest quarter, and the south-half of section number thirty-three (33); the southwest quarter and the southwest quarter of the southeast quarter of section number thirty-four (34); all in Township six (6) north of range five (5) east of the Willamette Meridian, containing nine hundred and twenty <920> acres, more or less,

That which, when surveyed, will be the east half of southeast quarter of section eighteen (18); the west-half of northeast quarter and southeast quarter of section thirty (30); the north-half of northwest quarter, the southwest quarter of northwest quarter and the northwest quarter of southwest quarter of section thirty-two (32) in Township six (6) north, range five (5) east of Willamette Mer., containing four hundred and eighty <480> acres, more or less;

That which, when surveyed, will be the southwest quarter, and southwest quarter of southeast quarter of section eighteen (18) and the west half of section thirty (30) in Township six (6) north, range five (5) east Willamette Meridian, containing five hundred and twenty acres, more or less.

To have and to hold the same, together with all and singular the appurtenances thereto and privileges thereto belonging, or in anywise thereto appertaining, and all the estate, right, title, interest and claim whatsoever of the said parties of the first part, either in law or in equity, either in person present or expectancy, to the only proper use, benefit and behoof of the said parties of the second part, their heirs and assigns forever.
