

Albert Wright et al. to Jack Connors

This Indenture, Made this 12th day of December in the year of our Lord one thousand nine hundred and 3, Between Albert Wright and James J. Hill, both of Washougal, Clarke County Washington, the parties of the first part, and Jack Connors of Portland Oregon, the party of the second part: Witnesseth, That the said parties of the first part for and in consideration of the sum of one Dollar and other valuable considerations, One Dollar of the United States of America, to us in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents remise, release and forever quit claim unto the first party of the second part, and to his heirs and assigns the following described Tract, lot or parcel of land, situate, lying and being in the County of Skamania, State of Washington, particularly bounded and described as follows, to-wit:

Located on Blue Jacket Creek, a tributary of the Blue Bird Creek, this claim is located at the foot of falls on Blue Jacket Creek falls 14 ft high 30 ft above falls about 30 ft high. Commencing Discovery at Post No 1, Thence 300 ft in a North Easterly direction to Cor. No. 2, Thence 1500 ft North Westerly direction to Cor. Post No 3, Thence 300 ft a South Westerly direction to center Post No 4, thence 300 to same direction to Cor. Post No 5, Thence 1500 ft south easterly to cor Post No 6. thence 300 ft north easterly direction to Place of beginning, Bounded on the West by the Hickman Mining claim in Bald Mountain Mining District, and known as the Pacific.

Together with all and singular the tenements, hereditaments and appurtenances therunto belonging, or in any wise appertaining and the reversion or reversions, remainder and remainders, rents, issues and profits thereof. To have and to hold, all and singular the said premises, together with the appurtenances, unto the said party of the second part, and to his heirs and assigns forever.
