

Jack Connors & wife to Bald Mountain Gold & Copper Co.

Know all men by these Presents, That I, Jack Connors and Katy Connors, his wife, in consideration of One Dollar and other valuable considerations to us paid by Bald Mountain Gold and Copper Company, a corporation, do hereby release, release and forever quitclaim unto the said Bald Mountain Gold and Copper Company and unto its successors and assigns all our right, title and interest in and to the following described parcel of real estate, situate in Skamania County, State of Washington, to-wit:

That certain mining location in Bald Mountain Mining District known as the "Pacific Mining Claim" located by Albert Wright and James F. Hill January 1, 1903, Notice of location recorded in Volume A page 548 record of Mining Claims of said County and according to the description contained in said recorded notice.

Also that certain mining location in Bald Mountain Mining District known as the "Wander Mining Claim", located by James F. Hill and Albert Wright January 1, 1903, Notice of location recorded in Volume B page 549 Mining records of said County and according to the description contained in said recorded notice.

And this Deed is executed to correct a similar conveyance made by us December 28, 1903 to the Copper King Mining and Milling Company recorded December 30, 1903 Volume A page 553 records of Deeds of said County. The greater in said Deed and the present one being identically the same corporation and the one from which the consideration was paid to us but because of refusal of the Secretary of state to file Articles under the name of Copper King Mining and Milling Company, the name of the present grantee was substituted thereon and no conveyance or grants bearing said name or any other except as in this conveyance given has ever paid or given us any consideration whatever for the property herein conveyed.

To Have and to Hold the same, together with all and singular the hereditaments and appurtenances thereto belonging or in any wise appertaining to the said Bald Mountain Gold and Copper Company and to its successors and assigns forever.
