Know all Men by these Presents, That Lillie Graaff (formerly Lillie Gumbiner, formerly Lillie Kilburn) and Julius S. Graaff her husband, of the County of Multnomah in the State of Oregon, for and in consideration of the sum of Seventy five hundred (\$7500.00) Dollars to them in hand paid by W. E. Murray and Rose E. Murray, of the County and State aforesaid, the receipt whereof is hereby acknowledged, have granted bargained and sold, and by these presents do grant, bargain, sell, convey and confirm unto the said W. E. Murray and Rose E. Murray and to their heirs and assigns forever, all of that certain tract of land lying and being in the County of Skamania State of Washington, and particularly described as follows to - wit:

The West half of the South West quarter of Section Twenty six (26) the East half of the South East quarter and the North West quarter of the South East quarter of Section Twenty - seven (27), all in Township two (27) North, Range six (6) East of the Willamette Meridian, and containing two hundred (200) acres more or less, together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining, and all of their right, title, interest, claim, possession or demand of any kind whatever, whether at law or equity, of in or to the above described premises, and each and every part and parcel thereof. To have and to hold, the same unto the said W. E. Murray and Rose E. Murray and to their heirs and assigns forever. And the said Lillie Graaff and Julius S. Graaff, her husband, do hereby covenant with the said grantees their heirs and assigns, that at the date hereof they are well seized in fee simple of the premises above conveyed, and they will and their heirs, executors and administrators shall warrant and defend the title thereto against the lawful claims or demands of any person or persons whomsoever.
