

Cyrus C. Wetherell to R. C. Haworth

Know all Men by these Presents, That Cyrus C. Wetherell and Nancy J. Wetherell, his wife of White Salmon, Klickitat County Washington, in consideration of One Hundred (\$100.00) Dollars, to them paid by Richard C. Haworth of Carson Wash., do hereby grant, bargain, sell, and convey unto said Richard C. Haworth, his heirs and assigns, all the following bounded and described real property, situated in the County of Skamania and State of Washington, to-wit: All of that part of the North side of the North West quarter of the North West quarter of Section six (6) Township ^{3 N.W.} eight (8) East Willamette Meridian, that lies North of a line running East between the North and South half of the North East quarter, Section One (1) Township Three (3) North of Range Seven and one half (7 1/2) East of Willamette Meridian - The said Cyrus C. Wetherell reserving the timber on said land and the right to remove the same and right of way for removal of same until Sept. 15. A. D. 1902, after which time said Cyrus C. Wetherell relinquishes all claims to timber, rights of way and all other claims whatsoever. Together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in any wise appertaining; and also all their estate, right, title and interest in and to the same, including Dower and claim of Dower. To Have and to Hold the same unto the said Richard C. Haworth his heirs and assigns forever. And Cyrus C. Wetherell and Nancy J. Wetherell his wife, grantors above named, do covenant to and with the above named grantees, his heirs and assigns, that the above granted premises are free from all encumbrances and that they will and their heirs, executors and administrators, shall warrant and forever defend the same against the lawful claims and demands of all persons whosoever.
