4. Also the following described parcel of real property situated in Woodlamn in said City of Portland, to-wit:

Feginning at a point where the west line of Willamette Avenue intersects the north line of Dekum Avenue (formerly Columbia Avenue) in said Woodlawn, as shown bt the recorded map and plats thereof; thence running west along the nortg line of said Dekum Avenue (formerly Columbia Avenue), to where the north line of said Dekum Avenue intersects the right of way formerly owned by the Portland and Vancouver Railway Company; thence in a northeasterly direction along the southerly line of said right of way of said Portland and Vancouver Railway Company towhere the southerly line of said railway night of way intersects the west line of said Willamette Avenue; thence in a southerly direction along the west line of said Willamette Avenue to the place of beginning; subject to any rights which the Oregon Land and Investment Company or its successors or assigns may heve, to lay and maintain water pipes and mains from its pumping station in said Woodlawn, over and across the property here being described;

- 5. Also the following described parcel of real property in said City of Portland to-wit: That certain parcel of land bounded on the north by the south line of the Lewis Love donation land claim, on the west by the center line of East Seventh Street on the south by the north line of block numbered forty (40) in Woodlawn, and on the east by ## the line of railway of the Railway Company;
- 6. Also the north forty (40) feet of lots numbered one (I) and two (2) in block numbered one (I) in Wait's Cloverdale Annex in said City of Portland;
- 7. Also that certain portion of block numbered six (6), in Ardmore in said City of Portland, (reference being had to the amended plat of said Ardmore, recorded at page II of book 308 or records of deeds of said Multnomah County, bounded and described as follows; Beginning at the northwest corner of said block numbered six (6), the same being the intersection of the easterly line of Ford Street with the southerly line of Madison Street in said City of Portland, and thence running southerly along the easterly line of Frod Street, being the westerly line of said block numbered six (6) one hundred and two and sixty-nine hundredths (IO2.69) feet to a boint which is the beginning point of the parcel of land here being described; thence running in an easterly direction in a line deflecting easterly twenty-two (22) degrees fifty-four (54) minutes from the center line of said Ford Street one hundred and fifty-sevenand six tenths (I57.6) feet, more or less, to the north line of Jefferson Street in said City of Portland; thence easterly along the north line of said jefferson Street fifty and ninety-five hundredths (50.95) feet to a point; thence in a northwesterly direction parallel with said line deflecting 22 54' casterly from the center line of said Ford Street (being the second line in this description) two hundred and sixty-five and eighty-six hundredths (265.86) feet, more or less, to a point in the north line of said block numbered six (6); thence westerly along the south of Madison Street and the north line of said block numbered six (6) eight and seventy-three hundredths (8.73) feet to the northwest corner of said block numbered six (6); thence continuing westerly along a westerly prolongation of the north line of said block numbered six (6) to its intersection with a northwesterly prolongation of said line deflecting twenty-two (22) degrees fifty-four (54') minutes easterly from the center line of Ford Street; and thence south twenty-two (22) degrees. fifty-four (54') minutes east to the west line of said block numbered six (6) to the point of beginning.
- 8. Also that certain portion of the Marcus Neff donation land claim bounded as follows:
