Ash and to her heirs and assigns forever, all of that certain tract of land lying and being in the County of Skamania, State of Washington, and particularly described as follows, to wit: Lots twelve $\{12\}$, Thirteen $\{13\}$, fourteen $\{14\}$, fifteen $\{15\}$, sixteen $\{16\}$, seventeen $\{17\}$, eighteen $\{18\}$, nineteen $\{19\}$, twenty $\{20\}$ and twenty-one $\{21\}$, of all in Block seven $\{7\}$ of the Town of Stevenson, as shown by the official plat of said Town now on file and of record in the office of the Auditor of Skamania County, Washington, together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining, and all of our right, title, interest, claim, possession or demand of any kind whatever, whether at law or equity, of, in or to the above described premises, and each and every part and parcel thereof.

And the said Mary Elizabeth Sweeney and John F. Sweeney, do hereby covenant with the said grantees, her heirs and assigns, that at the date hereof they are well seized in fee simple of the premises above conveyed, and they will and their heirs, executors and administrators shall warrant and defend the title thereto against the lawful claims or demands of any person or persons whomsoever.
