KNOW ALL MEN BY THESE PRESENTS: That RECONSTRUCTION FINANCE CORPORATION, a corporation organized and existing under and by virtue of an Act of Congress entitled "RECONSTRUCTION FINANCE CORPORATION ACT", approved January 22, 1933, is dissolved, and as reorganized by Reorganization Plan No. 1 of 1951, effective May 4, 1952, hereby revives and by these presents does revoke to one certain Powers of Attorney executed by it under dates of August 11, 1937, August 13, 1937 and January 13, 1942, appointing WILLIAM KENNEDY, of the City of Portland, County of Multnomah, State of Oregon, as true and lawful Agent and Attorney for certain purposes in said powers set out; and said corporation does hereby revoke and by these presents does revoke that certain Power of Attorney as to said WILLIAM KENNEDY only, executed by it under date of January 24, 1952, appointing the said William Kennedy and J. H. Cruickshank, of the City of Clackamas, County of Clackamas, State of Oregon, severally and not jointly, as true and lawful Agents and Attorneys for certain purposes in said power set out, which Power of Attorney as to said J. H. Cruickshank shall remain in full force and effect notwithstanding this Revocation of said Power of Attorney as to William Kennedy.
