This Indenture made this 1st day of November 1909 between Bank of Stevenson a Washington corporation of Stevenson, Washington, party of the first part, and Clarke A. LaBarre of Skamania County Washington, party of the second part:

Whereas the said party of the second part by indenture of mortgage, bearing date the 20th day of November 1908 and recorded in the office of the County Auditor for Skamania County Washington in Book H of Mortgages in page 370 on the 7th day of December 1908, did, for the consideration and for the purpose therein mentioned mortgage the premises therein described.

And whereas the said party of the second part has on this day paid to the said party of the first part the sum of one dollar, part of the money secured thereby as therein specified,

Now therefore, this indenture witnesseth: That the said Bank of Stevenson, party of the first part in consideration of the premises and the sum of one dollar duly paid to the said party of the first part by the said party of the second part at the time of the enrolling and delivery of these presents, the receipt whereof is hereby acknowledged, does by these presents, grant release, quitclaim and set over unto the said party of the second part, his heirs and assigns, all that part of the said mortgaged lands bounded and described as follows, to-wit:

The North half (N $\frac{1}{2}$ ) of the Northwest quarter (NW $\frac{1}{4}$ ) of the Northeast quarter (NE $\frac{1}{4}$ ) of Section twenty-eight (28) Township two North of Range five (5) East of Willamette Meridian. Together with all and singular the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining. and all the lien, right, title and interest of the said party of the first part, of, in and to the same to the intent that the lands hereby conveyed and released shall be discharged from said mortgage, and that the rest of the lands in said mortgage specified may remain to the said party of the first part as heretofore. To have and to hold the lands and premises hereby conveyed and released to the said party of the second part, his heirs and assigns forever.
