


State of Washington to Mary J. Hamilton

In Consideration of One hundred seventy-two and $\frac{89}{100}$ (\$172.89) Dollars, the receipt of which is hereby acknowledged, the State of Washington does hereby grant, bargain, sell and convey unto Mary J. Hamilton, her heirs and assigns, the following described shore land of the second class, situated in Skamania County, Washington, to wit:

All shore lands of the second class, owned by the State of Washington, embraced within the following boundaries, to-wit: Beginning at a point south $21^{\circ}58'$ east 41.27 feet from the southwest corner of the S. M. Hamilton S. L. C. in Township 2 north, range 7 east W. 16, thence south $66^{\circ}35'$ west 198.22 feet; south $67^{\circ}48'$ west 482.23 feet; south $85^{\circ}04'$ west 877.12 feet; north $86^{\circ}01'40''$ west 702.64 feet; north $82^{\circ}22'30''$ west 1969.85 feet; north $53^{\circ}11'$ west 154.60 feet; north 45° east 550.0 feet; north 71° east 1400.0 feet; north $48^{\circ}50'$ east 1050.0 feet; north $40^{\circ}41'$ east 1069.70 feet; south 260.0 feet to corner of fractional sections 29 and 30; thence south $71^{\circ}30'$ west 281.82 feet; south 42° west 1372.8 feet; south 60° west 396.0 feet; south $71^{\circ}45'$ west 1336.5 feet; south $46^{\circ}30'$ west 502.92 feet; south $37^{\circ}30'$ east 76.56 feet; south $76^{\circ}15'$ east 132.0 feet; south $83^{\circ}30'$ east 2538.36 feet; north $80^{\circ}13'$ east 472.86 feet to corner to fractional sections 29 and 30 on the north bank of Columbia River; thence north $85^{\circ}30'$ east 389.40 feet; north $71^{\circ}31'$ east 711.94 feet to the southwest corner of the said Hamilton S. L. C.; thence south $21^{\circ}58'$ east 41.27 feet to the place of beginning, containing 9.57 acres, more or less. Also beginning at the southwest corner of the S. M. Hamilton S. L. C. in said Township 2 north, range 7 east W. 16, thence by the following courses and distances: North $64^{\circ}28'$ east 1043.76 feet; north 62° east 452.0 feet; north $79^{\circ}55'$ east 90.37 feet; south 60° west 1060.0 feet; south $69^{\circ}27'$ west 530.2 feet; north $21^{\circ}58'$ west 41.27 feet, to the place of beginning, containing 2.01 acres, more or less, and altogether containing 11.52 acres more or less, including to the survey thereof, as shown by the plat and field notes of said described ^{shore} land, filed in the office of the Commissioner of Public Lands at Olympia, Washington, on the 30th day of June, 1896.

To have and to hold the said premises, with their appurtenances, unto the said Mary J. Hamilton, her heirs and assigns forever.
