John Mackey & wife to Ond L Irvin et al.

This Indenture of Deed, made and entered into this 9. day of September A. D. 1904,  
between John Mackey and Oliver H. Mackey his wife, of Skamania County, Washington  
the parties of the first part, and Ond L. Irvin, Ernest L Irvin, Pearl L Irvin and Earl L  
Irvin, of Multnomah County, Oregon, parties of the second part, witnesseth: That said  
parties of the first part, in consideration of the sum of Fifteen hundred Dollars (\$1500.00) to  
them in hand paid, by said parties of the second part, the receipt whereof is hereby acknowledged  
have granted bargained and sold, and by these presents do grant, bargain, sell and convey  
to said parties of the second part, their heirs and assigns, to each the undivided fourth, the  
following described real property, situate in the County of Skamania and State of  
Washington, to-wit: - Beginning at a point five (5) chains and seventeen (17) links west  
of the quarter post on the north boundary line of Section six (6) in Township one (1) North  
of Range six (6) East, Willamette Meridian, running thence in a southerly direction keeping  
the center of the canyon to its mouth, and thence continuing on the same course to the Cascade  
Road, thence following said Cascade Road west, nineteen (19) rods and fifteen (15) links;  
thence south to the Columbia River, there being a stone marked L for the corner, thence  
easterly along said Columbia River, following its meanderings to the east line of the land  
claim of Robert Mc. Clure, comprising west half of the North east quarter and lots one (1)  
and two (2) of said Section six (6) in said Township and Range, thence northerly along said  
east line of said land claim to the north boundary line of said Section six (6); and thence  
westerly theron to the place of beginning: comprising 97 acres of land, more or less;  
and the same being the identical tract of land conveyed by Deed of William & Thomas and
