

W. A. Gray to E. A. Sessions

This Indenture, Made this 5th day of May A.D. 1905, by and between W. A. Gray, of Lewis County, Washington, party of the first part, and E. A. Sessions in his own right and as Trustee for J. M. Gray, also W. A. Gray, the grantor herein, E. W. Simpson, R. Palitzsch, A. R. Zeller, and J. F. Boone, party of the second part, Witnesseth, that the said party of the first part in consideration of One Dollar, paid to said party of the second part by said party of the second part, the receipt whereof is hereby acknowledged, have bargained, sold, quit claimed and released and by these presents does bargain, sell, release and quit claim, unto said E. A. Sessions in his own name and as Trustee, successors and assigns, all the right, title, interest estate, claim and demand of the said party of the first part, of, in and to the following described Tracts, lots, or parcels of land, situate, lying and being in the County of Skamania State of Washington, particularly described and bounded as follows, to-wit:

Following quartz-miner locations, certificates of which are recorded in the Auditor's office of Skamania County, Washington, to-wit: Book B Mineral locations, page 480, same book, page 481, same book, page 482; same book page 482-3; same book 483-4; same book page 484-5; same book page 485; same book 486-7; same book 487; This deed is made to correct the error and mistake in that the name of W. A. Gray, the grantor herein, was by mistake signed to the location certificates above set forth as locator and claimant, when in truth and fact all the connection the said W. A. Gray had in making said locations was to post the notices of discovery and locations for the Germania Mining and Milling Co. a corporation that located said mining claims. This deed is not to affect the right of the grantor herein to his true interest in said claims as a shareholder in said Co. which the grantor holds in Trust. Together with all and singular the Tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversions and reversions, remainder and remainders, rents, issues and profits thereof. To Have and to hold The above quit claimed premises with all and singular the appurtenances, unto the said party of the second part, and to his heirs and assigns forever.
