

that may be recovered the sum of decreed by the court as attorney's fees to be taxed as a part of the costs in such suit as well as all payments that the said party of the second part her heirs executors or assigns may be obliged to make for her or their security by insurance or on account of any taxes assessments or incumbrances whatsoever on the said premises or any part thereof. In case of the foreclosure of this mortgage the party of the second part her heirs executors or assigns shall be entitled to have entered in the judgment a judgment for any deficiency remaining due upon account of the indebtedness secured hereby including taxes or other lawful assessments after applying the proceeds of the sale of said premises above described to the payment thereof and to the costs of such foreclosure suit.

This Indenture made this eighth day of January 1910 between Leland E. Bristol and Alice C. Bristol his wife parties of the first part and Oscar L. Loefer, Jesse D. Lavery, H.E. Babcock, E.C. Babcock, Myra B. Yowen, Retta O. Babcock, parties of the second part witnesseth: That the said parties of the first part for and in consideration of the sum of one thousand dollars lawful money of the United States to them in hand paid by the parties of the second part the receipt whereof is hereby acknowledged do by these presents grant, bargain, sell and convey unto the said parties of the second part and to their heirs and assigns the following described tracts or parcels of land lying and being in the County of Skamania State of Washington to-wit:

The West half of the Southwest quarter of Section fourteen Township three North of Range ten East of Willamette meridian; also a piece of land commencing at the point on section line 417.42 feet north of the Southeast corner of section fifteen in Township three North of range ten East of W.M., running thence North 64.9 feet, thence west 150 feet, thence south 904.9 feet thence East 150 feet to place of beginning containing 3.1 acres more or less, excepting from said first above described tract of land a certain tract of land hitherto deeded by Clarence H.
