Wash., party of the second part, here granted, bargained and sold, and by these presents do grant, bargain sell and convey unto the said party of the second part, and to his heirs and assigns, the following described real property, situated, lying and being in the County of Skamania, State of Washington ^{Suberty, five} to wit: All that portion of land situated in the Southwest quarter of the Southeast quarter of Section ~~Thirty-four~~, Township three North of Range seven East of W. M. bounded as follows: Beginning at the Northeast corner of the Southwest quarter of Southeast quarter of said section 25 Twp 3 N. R. 7 E, running thence West 66 rods and 6 feet to County road; thence along meander of County Road to South line of said quarter of quarter section, thence East 14 rods and 13 feet to S. E. corner of said 40 acre tract, thence North 80 rods to place of beginning, ^{containing 19 acres more or less.} To Have and to Hold, the said premises, with all the appurtenances, unto the said party of the second part, and to his heirs and assigns forever, and the said John F. Sweeney and Elizabeth Sweeney, parties of the first part; for themselves and for their heirs, executors and administrators, so hereby covenant to and with the said party of the second part, his heirs and assigns, that they are the owners in fee simple of said premises, and that they are free from all incumbrances and that they will Warrant and Defend the title thereto against all lawful claimants whatsoever.
