Witnesseth, That, whereas at a public sale of real estate held on the 8th day of July A.D. 1905, pursuant to a real estate tax judgment entered in the Superior Court of the County of Skamania on the 15th day of June A.D. 1905, in proceedings to foreclose tax liens upon real estate and an order duly issued out of said court, N. P. Anderson, and N.
