

Anton Edlund to Mc Coy Creek Mfg. Co.

This Indenture, Made the 20th Day of July in the year of our Lord one thousand nine hundred and five Between Anton Edlund (a single man) of Thomas Lewis County Washington, the party of the first part, and Mc Coy Creek Mining Company, the party of the second part, Witnesseth: That the said party of the first part, for and in consideration of Fifty Dollars lawful money of the United States of America to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, has granted, bargained, sold, remised and quitclaimed and by these presents does grant, bargain, sell, remise and forever quitclaim unto the said party of the second part, and to their heirs and assigns the following Mineral claims: The Minnette, situate on Mc Coy Creek in Skamania County Washington located April 22nd 1903 and recorded in Book B of Mineral Locations at page 605 Records of Skamania County, Wash. The Silver Dollar Mine situate in Skamania County, Wash. recorded on located May 21st 1903 and recorded June 13th 1903 in Book B of Mineral Locations at page 605 Records of Skamania County, Wash. The Ethel Lewis Mine, situate in Skamania County, Wash. located May 24th 1903 and recorded in Book B of Mineral Locations on June 13th 1903 at page 604 Records of Skamania County, Wash.
