Fouts to Stubling.

This Indenture Made this 14th day of April 1910 between P. F. Fouts and Seneca Fouts of the County of Multnomah State of Oregon, party of the first part, and A. C. Stubling of the County of Multnomah State of Oregon, party of the second part, Witnesseth: That the said parties of the first part for and in consideration of the sum of eight hundred and seventy five & no/100 dollars to me in hand paid, the receipt whereof is hereby acknowledged, have bargained and sold and by these presents do bargain, sell and convey unto the said party of the second part, his heirs and assigns forever, all the following described and bounded property, to-wit: SE 1/4 of the SW 1/4 and the South 1/2 of the SE 1/4 of section (9) nine and the SW 1/4 of the SW 1/4 of section (10) ten, all in Township three (3) North of Range nine (9) East of Willamette meridian, containing about 160 acres of land in Skamania County Washington. Together with the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining. And also the estate right title and interest of the said parties of the first part of, in and to the same. To have and to hold the herein before granted bargained and described premises with the appurtenances unto the said party of the second part his heirs and assigns forever.

This conveyance is indented as a mortgage to secure the payment of the sum of eight hundred and seventy five dollars in accordance with the tenor of a certain promissory note of which the following is a copy, to-wit:

Five months after date without grace, I promise to pay to the order of A. C. Stubling at Portland, Oregon, eight hundred seventy five dollars in Gold coin of the United States of the present standard value with interest therein in like gold coin at the rate of seven per cent per annum from date hereof until paid for value received. Interest to be paid at maturity and if not so paid the whole sum of both principal and interest to become immediately due and collectible
