

Northern Pacific Ry Co to Portland & Seattle Ry Co.

Deed No. 14565 W.

The Grantee, Northern Pacific Railway Company, a corporation of Wisconsin, for and in consideration of One Dollar and other valuable considerations to it paid, conveys and warrants to Portland and Seattle Railway Company, a Washington Corporation, the following described real estate in the County of Skamania, State of Washington, more particularly described as follows, to-wit:

A strip of land two hundred (200) feet in width, being one hundred (100) feet on each side of the center line of the main track of a line of railroad hereafter to be constructed by the grantee, and across lot four (4) of section thirty-five (35) in Township three (3) North, of range eight (8) East of the Willamette Principal Meridian; and lot five (5) of section twenty-five (25), lot three (3) of section thirty-two (32), lot four (4) of section thirty-five (35) all in Township three (3) North, of Range nine (9) East of the Willamette Principal Meridian.

Full authority is hereby granted to enter upon the premises hereinbefore described, over and across which a right of way is granted, for the purpose of marking definite location of said line of railroad. Upon the marking of said definite location and the staking out of said center line, this Deed shall operate as a conveyance of the fee simple title to the said described strip of land; provided said definite location is made and said line staked out within five (5) years from this date. And the grantor does hereby further release and relinquish the said grantee of all claims and demands for damages to adjacent and adjoining lands, by reason of the location, construction, maintenance and operation of a railroad upon the said strip of land, hereafter to be definitely located as provided by the terms of this Deed. This Deed shall run to the benefit of and be obligatory upon the heirs, executors, personal representatives, successors and assigns of the respective parties.
