together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining; and all of our right, title, interest, claim, possession or demand of any kind whatever, whether at law or equity, of, in or to the above described premises and each and every part and parcel thereof.

To have and to hold, the same unto the said Alice Moor, and to her heirs and assigns forever. And the said L. B. Bevans and Mabel Bevans do hereby covenant with the said grantees her heirs and assigns, that at the date hereof we are well seffred and free simple of the premises above conveyed, and we will and our heirs, executors and administrators shall warrant and defend the title thereto against the lawful claims or demands of any person or persons whatsoever.
