

over and across the following described piece or parcel of land, to-wit: Mining Claim filed as Garment Claim in

PROVIDED, that a road approach leading to mine tunnel and sufficient area near easterly shaft for material loading site.



and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same by examining, surveying, laying out and establishing said Road.

Giving and granting unto said County, Washington, the said Right-of-Way, with full power and authority to examine, survey, lay out and establish said Road as proposed, and to peacefully maintain the same as a County Road.
