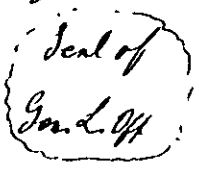


privileges, immunities, and appurtenances, of whatever nature thereunto belonging, unto the said Edward B. Perrin and to his heirs and assigns forever. And there is reserved, from the lands hereby granted, a right of way thereon for ditches and canals constructed by the authority of the United States. In Testimony Whereof, I, Theodore Roosevelt, President of the United States of America, have caused these letters to be made patent, and the seal of the General Land Office to be hereunto affixed. Given under my hand at the City of Washington, the first day of September in the year of our Lord one hundred and four, and of the Independence of the United States the one hundred and twenty sixth.

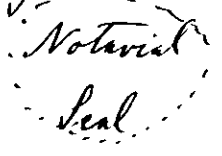
