W. $\frac{1}{4}$ of S. W. $\frac{1}{4}$ of Section 33 Township 2 North, Range 5 E. W. M. Being a strip of land 20 feet in width, adjacent to and parallel to the street on south side of Preachers Row Lots as on file in County Auditor's Office.



and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same by examining, surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-Way, with full power and authority to examine, survey, lay out and establish said Road as proposed and to peacefully maintain the same as a County Road.
