Trustee shall cancel the same and deliver the coupons of the bonds hereby secured, so paid, to the Timber Company, and the coupons of the bonds of the Railroad Company, so paid, to the Railroad Company. In the event of any default in the mortgage securing said bonds of the Railroad Company making desirable or necessary any action on the part of the holder or holders of the bonds of said Railroad Company, the Trustee is hereby fully authorized and empowered to take such action, in its discretaion, with or without the request or assent of the Timber Company.

The Timber Company covenants that it is the owner of the said bonds of the Railroad Company hereby conveyed as security, and has full authority and right to make this conveyance of the same.
