American Trust Co. to Cape Horn Rd. Co.

This Indenture made this sixth (6) day of July 1910 between the American Trust and Savings Bank an Illinois corporation, and Frank H Jones as trustee, both of the city of Chicago County of Cook State of Illinois, parties of the first part, and the Cape Horn Railroad company a corporation organized under the general railroad laws of the State of Washington, party of the second part Witnesseth: Whereas the said party of the second part for the purpose of securing the payment of its promissory note for one hundred fifty thousand dollars (\$150,000.00) did make execute and deliver to the said parties of the first part a certain indenture of mortgage or deed of trust dated November 14th 1908 and recorded in the office of the County Auditor of Skamania County Washington on December 4th 1908 in Book H of Mortgages, page 367 and, Whereas said note outstanding under and secured by said mortgage has been surrendered and cancelled; Now therefore the said parties of the first part do hereby certify that the said mortgage or deed of trust and the note secured by the same are satisfied and do hereby consent that said mortgage or deed of trust be discharged of record. And the said parties of the first part in consideration of the sum of One dollar to them paid by the said party of the second part have remised, released and quit claimed and by these presents do remise release and quitclaim unto the said party of the second part and to its successors and assigns forever all the property and premises, real and personal of every sort and description in said mortgage or deed of trust mentioned and described (reference being made to said mortgage or deed of trust for fuller description). Together with all the appurtenances thereof and all the estate right title and interest, property, possession claim and demand as well at law as in equity of the said party of the first part of, in and to the said property and premises and every part and parcel
