This Indenture Made this 3rd day of August 1910 between Schuyler Clark and Clara E. Clark his wife of Skamania County Washington, the parties of the first part and William Kellendonk of same place the party of the second part, Witnesseth: That the said parties of the first part for and in consideration of the sum of thirty-five hundred (\$3500.00) dollars to them in hand paid by the party of the second part, the receipt whereof is hereby acknowledged do by these presents grant, bargain, sell and convey unto said party of the second part and to his heirs and assigns the following described tract or parcel of land lying and being in the County of Skamania State of Washington and bounded and described as follows:

Beginning at the Northeast corner of the Northwest quarter of the Southeast quarter of Section 15 Township 3 North of Range 10 East of W.M.; thence <sup>West 9 rods, thence</sup> south 40 rods; thence East 9 rods, thence North 40 rods to point of beginning. Beginning at the southeast corner of the Northwest quarter of the southeast quarter of section 15 Township 3 North of Range 10 East of W.M. thence west 31 rods, thence north 40 rods, thence east 31 rods, thence south 40 rods to point of beginning. Together with all and singular the tenements hereditaments and appurtenances thereunto belonging.
