Stevenson et al to Bank

This Indenture made this sixteenth day of August 1910 between J.M.Stevenson and Minnie Stevenson his wife of portland, Oregon, George H Stevenson and Rebecca A.Stevenson his wife of Tacoma, Washington and Otto Stendahl of Seattle Washington parties of the first part and Bank of Stevenson, party of the second part witnesseth:

That the said parties of the first part for and in consideration of the sum of thirty five hundred and no/100 (\$3500.00) dollars lawful money of the United States to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said party of the second part and to its successors and assigns the following described tracts or parcels of land lying and being in the County of Skamania State of Washington to-wit:

Beginning at a point on the west line of the D.F.Bradford Donation land claim No.37, the same being a point on the east line of the Isaac H. Bush Donation land claim No.296, five and ninety hundredths (5.90) chains north, twenty nine degrees (29°) east of the quarter section corner on the west side of section eleven (11) in Township two (2) North Range seven (7) East of Willamette meridian, which is also an angle corner of the said claims as described by the Surveyor General; thence west thirty three and forty hundredths (33.40) chains; thence south eighty (80) chains; thence east fifty and thirty hundredths (50.30) chains intersecting the west boundary of the donation claim of D.F.Bradford at a point four and ninety hundredths (4.90) chains north of the angle corner as described by the Surveyor General; thence north thirty five and ten hundredths (35.10) chains; thence west three and ninety five (3.95) chains; thence north twenty three (23) degrees west forty two and fifty hundredths chains (42.50), thence North twenty nine degrees (29) east, five and ninety hundredths (5.90) chains to the point of beginning, containing three hundred fifty six and eight hundredths (356.08) acres; being the Isaac Bush Donation Land claim number 296.

Also Lots four, five, six and nine (4, 5, 6, 9) of section ten (10) in Township two (2) North of Range seven (7) East of W.M., Together with all and singular the tenements hereditaments and appurtenances thereto belonging, excepting the timber.

This conveyance is intended as a mortgage to secure the payment of thirty five hundred (\$3500.00) dollars lawful money of the United States, together with interest thereon at the rate of eight per cent per annum from date until paid, according to the terms and conditions of one certain
