The Grantor for and in consideration of the sum of Fourteen hundred and ninety nine (\$1499.) Dollars in hand paid, convey and warrant to the Portland and Seattle Railway Company, a Washington corporation its successors and assigns, the following described real estate situated in the County of Skamania and Klickitat, State of Washington, viz: A strip of land one hundred feet in width being fifty feet in width on each side of the center line of the railroad of said Railway Company, so now located, staked out and to be constructed over and across the West half $\frac{1}{2}$ of Lot One $\#1$ and the East half $\frac{1}{2}$ of Lot Two $\#2$ of Section Twenty three $\#23$ in Township Three $\#3$ North Range Ten $\#10$ East. At the time and consideration above being in full settlement of all claims and demands for damages sustained by reason of location, construction, maintenance and operation of said railroad and from said grantee.
