Strong of Portland Oregon, the receipt whereof is hereby acknowledged, have granted, bargained and sold, and we do by these presents grant, bargain, sell and convey unto the said Thomas N. Strong and to his heirs and assigns the following described premises, namely:

The north half of the northwest quarter, the northwest quarter of the northeast quarter and lots one (1) two (2) three (3) and four (4) of Section four (4) and lot two (2) of section three (3) in Township one (1) north of Range six (6) east of the Willamette Meridian and the west half of the southwest quarter of section thirty-four (34) Township two (2) North of Range six (6) east of the Willamette Meridian, containing in the aggregate 388²⁵/₁₀₀ acres of land situated in Skamania County, State of Washington. Together with all and singular the Tenements, hereditaments and appurtenances thereto belonging or in any wise appertaining. To have and to hold the above granted and described premises unto him the said Thomas N. Strong and to his heirs and assigns forever. And we the said W. Byron Daniels & Rosina A. Daniels his wife for ourselves, our heirs and executors and administrators do covenant with the said Thomas N. Strong his heirs and assigns that we are the lawful owners in fee simple of the said premises, that they are free from all liens and incumbrances whatever and we will and our heirs, executors and administrators shall forever warrant and defend the same against all lawful claims whatever.
