Know all men by these presents that John H. Palm, party of the first part, in consideration of the sum of four hundred dollars (\$400.00) lawful money to him in hand paid by Joe Barboo, party of the second part, the receipt whereof is hereby acknowledged, has sold and assigned and by these presents does sell transfer and assign unto the said party of the second part and his assigns a certain indenture of Mortgage bearing date the 13th day of September 1907 made and executed by Herbert Graham and Ellen Graham to John H.
