Know all men by these presents that we, Clinton Wood and Matilda Wood, executors of the last Will and Testament of Alfred Wood, deceased, the parties of the first part, for and in consideration of the sum of \$1000.00 lawful money of the United States to us in hand paid by the Bank of Stevenson, a corporation, the party of the second part, the receipt whereof is hereby acknowledged have granted, bargained, sold, assigned transferred and set over and by these presents do grant, bargain, sell assign transfer and set over unto the said Bank of Stevenson, a certain Indenture of Mortgage, bearing date the 18th day of March 1908 made and executed by Alden Kingman and Emma Kingman, his wife, the parties of the first part named therein, to secure the payment of the sum of \$4000.00 together with the promissory notes or obligations therein described, and the money due or to grow due thereon, with interest, which said Indenture of Mortgage was recorded in the office of the County Auditor of the County of Skamania State of Washington in Book H of Mortgages Page 145 and the 26th day of March 1908, and was thereafter assigned by deed of assignment to Alfred Wood, now deceased, which assignment was recorded in Book H of Records of Mortgages page 336 in the office of the County Auditor of Skamania County Washington.
