Lyman to Oregon Mortgage Co. Ltd.

This Indenture made this ninth day of November 1910 by and between C.W. Lyman and Daisie B. Lyman his wife of the county of Skamania state of Washington, hereinafter called the mortgagors and The Oregon Mortgage Company Limited (a corporation duly incorporated under the laws of Great Britain and Ireland), hereinafter called the mortgagee, Witnesseth: That the said mortgagors for and in consideration of the sum of five thousand (\$5000.00) dollars United States Gold Coin, to them in hand paid the receipt whereof is hereby acknowledged have granted, bargained and sold and by these presents do grant, bargain, sell and convey unto the said mortgagee its successors and assigns those certain premises situate in the County of Skamania state of Washington: The south half of the Northeast quarter, and the south half of the Northwest quarter of section eighteen in Township one North of Range five East of Willamette Meridian, excepting beginning at the southwest corner of section eighteen in Township one north of Range five East W.M. running thence 80 rods East; thence 20 rods north, thence 80 rods west thence 20 rods south to place of beginning, containing 10 acres. The land hereby conveyed contains one hundred and fifty acres more or less; together with all the rights to the use of water for irrigating said premises and for domestic purposes thereon to which the said mortgagors or the premises hereby conveyed are now or may hereafter become entitled and together with all shares of stock or shares of water in any ditch or irrigation company, which in any manner entitle said mortgagors to water for irrigating purposes upon said premises. Together with all and singular the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining, together also with the rents issues and profits of the mortgaged premises including the crops sown or to be sown or grown thereon. To have and to hold the same unto the mortgagee its successors and assigns forever.
