Northern Pacific Railway Company.

This Deed, made the thirty-first day of January, in the year of our Lord one thousand nine hundred and six, by the Northern Pacific Railway Company, a corporation duly organized and incorporated under the laws of the State of Wisconsin, party of the first part, and the Portland and Seattle Railway Company, a corporation duly incorporated under the laws of the State of Washington, party of the second part, Witnesseth: Whereas, by Deed dated September 8, 1905, between the parties hereto the Northern Pacific Railway Company granted a strip of land two hundred (200) feet wide, namely, one hundred (100) feet in width on each side of the center line of the railroad of the Portland and Seattle Railway Company, to be hereafter staked out and located over and across lot four (4) of section thirty-five (35) in Township Three (3) north, of range eight (8) east of the Willamette Principal Meridian; and lot five (5) of section twenty-five (25), lot three (3) of section thirty-two (32), lot one (1) of section thirty-five (35) all in Township Three (3) north, of range nine (9) east of the Willamette Principal Meridian, together with the right to enter upon said premises and locate and construct thereon a railroad; and Whereas, said Portland and Seattle Railway Company has now staked out and located the line of its railroad across the premises above described and has duly adopted such location; Now Therefore, the party of the first part, in consideration of the premises and of the sum of one (1) dollar unto it paid, does grant, convey and confirm unto the party of the second part a strip of land two hundred (200) feet wide, bounded and by two lines each of one hundred (100) feet distant from and parallel with the center line of the railway of the Portland and Seattle Railway Company as now staked out and located over and across the said lot four (4) of section thirty-five (35) in Township Three (3) north, of range eight (8) east of the Willamette Principal Meridian; and lot five (5) of section twenty-five (25) lot three (3) of section thirty-two (32) lot one (1) of section thirty-five (35) all in Township Three (3) north, of range nine (9) east of the Willamette Principal Meridian, situated in the County of Skamania, State of Washington.
