Haffey to Duggan

This Indenture made this 7th day of December 1910 between J.T. Haffey and Lulu Haffey his wife, parties of the first part, and Walter Duggan, party of the second part witnesseth:

That the said parties of the first part for and in consideration of the sum of six hundred dollars lawful money of the United States to them in hand paid by the said party of the second part the receipt whereof is hereby acknowledged have bargained and sold and by these presents do grant, bargain, sell and convey unto the said party of the second part the following described tract or parcel of land lying and being in the County of Skamania State of Washington and bounded and described as follows to-wit: Beginning at the southwest corner of a tract of land heretofore set apart out of the estate of William Haffey deceased, for Cornelius Haffey and later deeded by him to John T.
