

Co. Treasurers to Caroline Sholin

This Indenture, made the 23^d day of March 1906, between J. A. Fisher, County Treasurer of the County of Skamania, State of Washington, party of the first part, and Caroline Sholin, party of the second part, Witnesseth: Whereas, the Board of County Commissioners of Skamania County did heretofore and on the 11th day of November, 1904, give notice in the manner provided by law, of their intention to sell the real property belonging to the County of Skamania hereinafter described, and Whereas, at the time designated in such notice, to-wit: on the 2^d day of January 1905, said Board of Co. Commissioners did meet at their usual place of meeting to hear and determine the advisability of making said sale, and did determine to make said sale, which said determination was spread upon the minutes of said meeting and made a matter of record, and an order entered upon their minutes directing the auditor to give notice of such sale, and Whereas the auditor of said County did thereafter give duly notice of said sale in the manner provided by law and the real property hereinafter described was sold by the Sheriff of said Skamania County, at the door of the Courthouse and Whereas the party of the second part, Caroline Sholin, at such sale was the highest bidder and best bidder, and has paid the sum bid for said property to the County Treasurer of said County:

Now Therefore in consideration of the premises, and by virtue of authority vested in the undersigned party of the first part, the said party of the first part does hereby sell and convey unto the party of the second part, her heirs, executors, administrators and assigns the following described real property, situated in the County of Skamania, State of Washington, to-wit: Lot nine of Block five, in the Town of Stevenson, Skamania County, Washington, according to the official plat thereof now on record in the office of the County Auditor of said County.
