

A. C. Sly to P. & S. Ry. Co.

The Grantor for and in consideration of the sum of twenty-five hundred dollars, as herein paid, convey and warrant to the Portland and Seattle Railway Company, a Washington corporation, its successors and assigns, the following described real estate situated in the County of Skamania, State of Washington, viz.: A strip of land fifty feet in width on the south side of and parallel with said one hundred feet in width on the north side of and parallel with the center line of the railroad of said Railway Company as now located, staked out and to be constructed over and across that part of the Henry Shepard Donation Land Claim in section one, Township two north, range seven east of the Willamette Meridian, described as follows, to-wit:

Beginning at the southwest corner of Front Street in the town of Stevenson, Skamania County Washington, running thence south $40^{\circ}30'$ east to the south line of the Henry Shepard Donation Land Claim; thence in a southwesterly direction with the meanders of said south line to the southwest corner of said Shepard S. L. C., thence north on the west line of said Shepard Donation Land Claim to a point 25 feet north of a point due west of the northwest corner of Cascade Avenue and Hamill Street, thence back to where said line intersects the north line of Cascade Avenue, thence southwesterly on said north line to the corner of said Cascade Avenue and Hamill Street, thence south on the west line of said Hamill Street to place of beginning. Also over and across a tract of land described as follows, to-wit:

Beginning at the southeast corner of lot six in section one, Township two north, range seven east of the Willamette Meridian, running thence North 4.40 chains, thence west 4.55 chains, thence south 4.40 chains and thence east 4.55 chains to place of beginning, containing two acres, more or less, and the shoulders adjacent thereto, including the preference right of the grantor herein to purchase the portion of said shoulders contained within said strip; and consideration also being in full settlement of all claims and demands for damages sustained by reason of the location, construction, maintenance and operation of said railroad on, over and across said described land.

The grantor reserves the right to remain in possession thereof until from the date of this deed without payment of rent, and also reserves the right to remove all buildings on said premises.
