

State of Washington to Myrtle Hamilton

In consideration of Two hundred eighty-eight and $\frac{55}{100}$ (\$288.45) Dollars, the receipt of which is hereby acknowledged, the State of Washington does hereby grant, bargain, sell and convey unto Myrtle Hamilton her heirs and assigns; the following described shore land of the second class, situate in Skamania County, Washington to-wit: Beginning at the southeast corner of the E. C. Hardy Section Land claim, Township 2 north, range 7 east W. M. and running thence south 100 feet; south $51^{\circ}50'$ west 700 feet; south $25^{\circ}30'$ west 560 feet; south 58° west 1128 feet; south $71^{\circ}26'$ west 716.13 feet; south $68^{\circ}53'$ west 432.80 feet; south 43° west 660 feet; south 48° west 600 feet; south $76^{\circ}42'$ west 927.23 feet; south $83^{\circ}56'$ west 550.90 feet; north $87^{\circ}19'$ west 213.15 feet; north 46.21 feet to southwest corner of E. C. Hardy S. L. C.; east 131.00 feet to corner to fractional sections 25 and 30; north $86^{\circ}30'$ east 495 feet; north 74° east 396 feet; north $62^{\circ}45'$ east 957 feet; north 48° east 660 feet; north $63^{\circ}15'$ east 330 feet; north $75^{\circ}45'$ east 151.50 feet; north $70^{\circ}30'$ east 759 feet; north $61^{\circ}45'$ east 363 feet; north 35° east 132 feet; north 46° east 257.40 feet; north 41° east 528 feet; north $50^{\circ}15'$ east 330 feet; north $36^{\circ}15'$ east 148.50 feet; north 57° east 307.50 feet; north $128^{\circ}30'$ east 64 $^{\circ}47'30''$ east 387.48 feet to the place of beginning, containing 14.66 acres, more or less. Also, beginning at a point 156.28 feet south and 115.67 feet east of the corner to fractional sections 25 and 30, Township 2 north, ranges 6 & 7 E. W. M., and running thence north $83^{\circ}57'$ east 676.30 feet; north $57^{\circ}33'$ east 469.40 feet; north $35^{\circ}03'$ west 260 feet; south $58^{\circ}06'$ west 598 feet; south $61^{\circ}53'$ west 466.70 feet to the place of beginning, containing 4.57 acres, more or less.
