

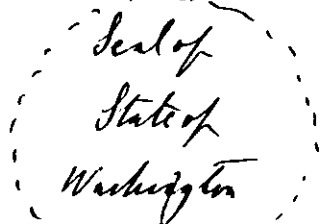
State of Washington to Skamania Boom Co.

In consideration of seven hundred ninety-one and $\frac{1}{100}$ (\$791.10) Dollars, the receipt of which is hereby acknowledged, the State of Washington does hereby grant, bargain, sell and convey unto the Skamania Boom Company, a corporation, its successors and assigns, the following described shore land of the second class situate in Skamania County, Washington, to-wit: All shore lands of the second class, owned by the State of Washington, embraced within the following described boundaries, to-wit:

Beginning at a point on the government-meander line, being the meander corner of fractional sections 33 and 34, which is a point 6.85 chains south of the corner to sections 27, 28, 33 and 34, Township 3 north, Range 8 east W. M., thence by the following courses and distances; north 75° west 6.40 chains; north $76^{\circ}20'$ west 8.75 chains; south 79° west 2.60 chains; north 83° west 29.00 chains to meander corner between sections 28 and 33; thence north 77° west 20.00 chains, west 11.50 chains; north 61° west 4.00 chains; north 4.00 chains; north 20° east 12.40 chains; north 63° west 5.00 chains to meander corner between fractional sections 28 and 29; thence south 42° west 8.50 chains; south 16° west 7.65 chains; south 52° west 7.00 chains; north 85° west 6.50 chains; west 14.85 chains; south 68° west 19.20 chains to the meander corner between fractional sections 29 and 32; thence south 67° west 2.55 chains; south 85° west 13.50 chains; south 20° west 11.80 chains; south 78° west 4.00 chains; south 75° west 4.70 chains; south 2.10 chains to meander corner between fractional sections 31 and 32 which is 15.20 chains south (Var. 20° east) of the corner to sections 29, 30, 31 and 32, to low water line in the Columbia River; thence along the line of low water north $75^{\circ}45'$ east 11.65 chains; north $17^{\circ}40'$ east 9.85 chains; north $76^{\circ}40'$ east 10.90 chains; north $69^{\circ}20'$ east 21.40 chains; east 21.55 chains; south $83^{\circ}02'$ east 79.95 chains; south $74^{\circ}30'$ east 15.19 chains; north 2.57 chains to the place of beginning, being the meander corner between fractional sections 33 and 34, containing 52.74 acres more or less, and being shorelands situated in front of sections 28, 29, 32 and 33, Township 3 north, Range 8 east of the W. M., all as shown by the plat and field notes of the said described shore lands, filed in the office of the Commissioner of Public Lands of the State of Washington, at Olympia, Washington, on the 5th day of January, 1897.

To Have and to Hold the premises with their appurtenances, unto the said The Skamania Boom Company, a corporation, its successors and assigns forever.
