Know all men by these presents, That we, Abner St. Ores and Louise St. Ores, husband and wife, of Butler, of the county of Stannan, in the State of Washington, for and in consideration of the sum of One thousand Five hundred dollars, to us in hand paid by Mary Storguin (formerly Mary Wil-Wy-i-tit), of Butler, of the county of Stannan, State of Washington, the receipt of which is hereby acknowledged have granted, bargained and sold, and by these presents do grant, bargain, sell, convey and confirm unto the said Mary Storguin and to her heirs and assigns forever, all of that certain tract of land lying and being in the county of Stannan, and State of Washington, and particularly described as follows, to-wit:

The South-half of the South West quarter and the North West quarter of the Southwest quarter of Section Thirty-three (33) in Township Two (2) North of Range six (6) East of Willamette Meridian, containing one hundred and twenty (120) acres, together with all and singular the Tenements, and hereditaments and appurtenances thereto belonging or in anywise appertaining, and all of our right, title, interest, claim, possession or demand of any kind whatever, whether at law or equity, of in or to the same, and each and every part and parcel thereof.

To Have and to Hold, the same unto the said Mary Storguin and to her heirs and assigns forever. And we, the said Abner St. Ores and Louise St. Ores, do hereby covenant with the said grantee, her heirs and assigns, that at the date hereof we are well seized in fee simple of the premises above conveyed, and we will and our heirs, executors and administrators shall warrant and defend the title thereto against the lawful claims or demands of any person or persons whomsoever.
