Know all men by these Presents, That Margaret Inman, widow of Felix G. Inman, deceased, unmarried of lawful age, in consideration of one Dollar and other valuable considerations, to her paid by Josiah M. Inman, do hereby remise, release and forever Quitclaim unto the said Josiah M. Inman and unto his heirs and assigns, all my rights, title and interest in and to all that parcel of real estate, situate in Skamania County, State of Washington, to-wit:

The $W\frac{1}{2}$ of the $S\frac{1}{4}$ and the $E\frac{1}{2}$ of the $SW\frac{1}{4}$ of Sec. 35 in T₃ S. N. of R 7 E. W. M., also an undivided $\frac{3}{4}$ of all that certain tract or parcel of land described as follows: Beginning on the bank of the Columbia River at low water mark at the S.E. corner of the Daniel Baughman Donation claim thence North 9 chains to the N.E. corner of said claim, thence ~~thence~~ west on the N boundary of said claim about 76 chains to the N.W. corner of said claim thence south on the west line of said claim 9.09 chains, thence in a straight line to a point on the bank of the Columbia River marked S. B. and F. S. J., thence up the Columbia River at low water mark following the meander line of said River to the place of beginning, containing 167 $\frac{1}{2}$ acres more or less, saving and excepting therefrom rock creek Island which was heretofore conveyed by my father and mother to Clarence Villett and also about 6 acres heretofore conveyed to Louis F.
