

Wright to Hosford & Morrill

Know all men by these presents that Robert P.Wright and Estella E.Wright his wife,having received the sum of One Dollar as a partial payment on that certain mortgage executed by L.P. Hosford and Effie Hosford,Roscoe R.Morrill and Fay Morrill,mortgagor,dated May 29th 1909 in favor of Robert P.Wright,recorded in Book H record of mortgages for the County of Skamania State of Washington on page 489 on the 4th day of June 1909 does hereby release from the lien of said mortgage the following desc ribed premises herein,to-wit:

Starting at the Northwest corner of the southwest quarter of section 6 Township one North of Range five East of Willamette Meridian running thence East on the quarter section line of Section 6 four hundred and six feet to a point;thence south two thousand and ten feet more or less to the Caoe Horn County Road;thence easterly foll wing said county Road about 902 feet to where same interestcs the Marrin Didier private road,which road adjoins on the west a 12 $\frac{1}{2}$ acres tract of land heretofore conveyed by H.P.Davis and wife to Joseph H.Didier,deed recorded in Book I of Deeds page 149;thence southwesterly along said Didier west line and private road 36 rods more or less to the southboundary line of section 6;thence west along the said South boundary line to the southwest corner of said section 6,thence North along west boundary line of Section 6 2640 feet to the northwest corner of the southwest quarter of section 6, which corner as the point of commencement,containing 34 and 10/100 acres of land, and that the remainder of sid lands in said mortgage specified shall remain subject thereto as heretofore.
