Tyler Woodward, trustee, to Security Savings & Trust Co.

Know all men by these presents, that we, Tyler Woodward, Trustee, and Mary J. Woodward, wife of the said Tyler Woodward, of the City of Portland, Oregon, in consideration of one dollar to us in hand paid by the Security Savings & Trust Company of Portland, Trustee, a corporation duly incorporated, organized and existing under the laws of the State of Oregon, having its principal place of business at Portland, in said State of Oregon, have granted bargained and sold, and by these presents do grant, bargain, sell, and assign, convey and confirm unto it, the said Security Savings & Trust Company of Portland, Trustee, its successors and assigns, all the following described pieces, parcels, lots and tracts of land, situate, lying and being in the County of Skamania, State of Washington, to-wit:

The southwest quarter of the southeast quarter of section fourteen (14) and the northwest quarter of the Northeast quarter of section twenty three (23) Township three (3) north of Range nine (9) east, containing eighty (80) acres.

Also beginning at a stake at the northwest corner of the southwest quarter of the northwest quarter of section one (1), Township three (3) north of range nine (9) east of the Willamette Meridian, and running thence east eighty (80) rods, thence south thirty rods (30); thence west eighty (80) rods, thence north thirty (30) rods, to the place of beginning, being fifteen (15) acres, situated in the southwest quarter of the northwest quarter of section one, Township three north of Range nine east.

Also the southwest quarter of Section one (1) Township three (3) north of Range nine east, containing one hundred and sixty (160) acres, known on the plat on file in the United States Land office at Vancouver, Washington, as the Mary A.
