Power of Attorney

And the execution of such bonds or undertakings in pursuance of these presents, shall be as binding upon said Company, as fully and amply, to all intents and purposes, as if they had been duly executed and acknowledged by the regularly elected officers of the Company at its office in Baltimore, Maryland, in their own proper persons. **This power of attorney revokes that issued on behalf of Kim Bishop, dated November 18, 1964.**
